

Risk Management & Safety Case Study:

Masonry Contractor

Challenge: A masonry contractor was concerned about the jobsite safety of his crew. He had seen job costs escalate and schedules delayed by untimely accidents, and his business had been victimized by fraudulent claims. All of these setbacks adversely impacted their workers' compensation insurance rates and affected their ability to be competitive within the marketplace.

Solution

The company engaged G&A Partners to provide HR and administrative services through a professional employer (PEO) arrangement, including affordable workers' compensation insurance and comprehensive risk management and safety services.
